Course Description:				
A detailed study of the relationship between church and state can be essential for anyone who seeks to understand Christianity's present situation in the World and wants comprehend the Western tradition of government, law and society. Historically, that relationship has taken a variety of forms from the state dominating religion; to religion dominating the state; and recent attempts to separate them.				
Goals:				
This course designed to acquaint students with the formative events, persons and teachings which shaped the relationship between the Christian Church and the secular powers from the Early Christianity to the Reformation Era by the examination of the English translations of original sources. All assigned reading will be provided in electronic format.				
Requirements:				
Regular reading of the assigned excerpts. Participating students will have to give a presentation in class with handouts, lead discussion about a chosen topic, and submit a 6-8 pages long seminar paper at the end of the course OR two presentations in class with handouts and discussion lead about two chosen topics without submitting seminar paper.
